Degree Course can obtain the application meant for NRI Quota from The Chairman, Law Admissions 2018-19, The Tamil Nadu Dr. Ambedkar Law University, Chennai, in person on submitting a demand draft (drawn in favour of the Registrar, The Tamil Nadu Dr. Ambedkar Law University, payable at Chennai) for US \$ 200 for each course as cost of application with a request letter mentioning name of the course.
